Minutes of the Annual General Body Meeting of All India Agricultural Students Association (AIASA) held on 29th December, 2012 at New Delhi

The Annual General Body Meeting of AIASA(AGM) was held on 29.12.2012 at 4:30 PM, IARI campus, New Delhi under the chairmanship of shri. Biswajit Mondal, National President, AIASA. Since the Coram could not be met, therefore, meeting was adjourned for half an hour and reassemble at 5:00 PM. The list of participants is annexed.

The National President welcomed the members, associate members and advisors for taking keen interest for carrying out the activities of AIASA for welfare of agriculturists/agriculture in different parts of the country. The following issues were discussed and decision taken:

- I. Budget & Account matters:** The Treasurer of AIASA presented the details of expenditure incurred/likely to be incurred and sought approval for the budget for the year 2013. The Treasurer presented the details of expenses of Rs.50,000/- incurred during the year 2012 and sought the approval of AGM of about Rs.75,000/- budget for 2013. It was mentioned that the Association got printed 128 receipt books for registration of students in different Universities. The payments will be made after receipt of bills. It was informed that final tally of expenditure will be made by end of March, 2013.
- II. Handing over and taking over charge by Executive Committee:** The National President informed the house that AIASA has been registered under societies Registration Act, 1860 vide registration No.S/RS/SW/0522/2011 on 1.12.2011. The Association has got Permanent account Number(PAN). It was informed that the present Executive Committee has taken over charge from previous Executive Committee on 1.3.2012. The new Executive Committee will take finance and account charge after completion of account in April, 2013 or thereafter. The General body passed the resolution as under:

“Resolves that new Executive committee will take charge from the Existing Executive Committee after April, 2013 and will continue to function till 31st December,2013 in accordance with bye-laws of the Society and further resolves that an intimation

will be given to SBI, Beej Bhawan alongwith specimen signature of the authorized officer for operating the account of the Association. The decision taken by existing Executive committee will be valid till completion of the account.”

III. Membership Drive: It was decided to enroll all the students pursuing their degree/diploma in agriculture and allied sciences (Agriculture, Veterinary, Fishery, Animal Husbandry, Dairy, Horticulture, Agricultural Engineering, Forestry, Agri-Business Management etc.) in the country as members of the Society and agricultural professional as associate members of the society. University coordinator of each Agricultural University/ Deemed University/Central Agricultural University/Autonomous or Recognized Agricultural Colleges/Institutions under the networking of Vice-president and Joint-secretary of their respective zones (East, West, North, South, Central and North East Zones) in coordination with Chief coordinator and Senior Vice President, General Secretary of the association, will initiate membership drive. The General body has fixed the target to enroll 100,000 students as members by end of December, 2013.

IV. Election of Executive committee: The Association appointed Dr.Mahesh Yadav, Principal Scientist, NBPGR(ICAR) as Returning Officer on 7.12.2012 as per clause 9(i) of the constitution of AIASA, for conducting election for various office bearers of Governing Body of the Association(AIASA), for the year 2013. Based on the nominations received and consensus reached among the members of Association, the following persons were declared elected unopposed in the Annual General Meeting of AIASA held on 29.12.2012 at IARI, New Delhi:

The AGM authorized National President to fill up Vacant posts in consultations Chief Coordinator and concerned Vice Chancellors/members of the Association in Agricultural Universities/colleges.

- V. Constitution of Advisory Board of AIASA:** Shri.J.P.Singh, Secretary General, AIFAA and Advisor, AIASA has proposed that there should be time to time dialogue among the Senior Officers, MPs, representatives of Students, farmers, Industry and other stake holders for reaching consensus on the important issues faced by agriculture community and for taking it up with higher authorities with recommendations for possible solution. It was unanimously decided to constitute Advisory Board of 100-150 members comprising Senior Government Officers, Vice Chancellors, Directors of Central/State Depts of Agriculture/Horticulture/Veterinary Sciences and representatives of Industry, scientists, students, farmers/NGOs and other stake holders. National President will approach Chairman, ASRB or any other senior officer(s) for seeking consent of holding the post of Honorary Chairman, Advisory Board and he will also make communications to Vice Chancellors, directors and representatives of Farmers, Scientists, Students, Industry and other stake holders for memberships of the Board.
- VI Website of AIASA:** Decision was also taken to resolve the technical problems of the website of association (www.aiasa.co.in) after having a meeting with the representatives of AIASA with its web engineer. It was decided to pay balance amount of Rs.25000/- to web engineer for settlement of website issues. The registration renewal charges of the website app Rs.5000/- will also be paid by society. It was decided to continue our website at www.aiasa.in till the time the matter is resolved with web designer.
- VI. Appointment of College/Local coordinators:** It was also decided that the University Coordinators can nominate a few numbers of college coordinators/ local coordinators at different colleges to have more accessibility to the members. Facilitators will be duly appreciated but they will not be the part of National executive committee because of limitation of maximum number of executives as 75.
- VII. Appointment of Coordinators at AIASA HQ:** It was decided to appoint 40-45 Coordinators/Senior Coordinators at AIASA HQ for effective monitoring and functioning of the Association. Mr.Manjit Mahadev Lad, Chief Coordinator presented the list of

45 coordinators/Senior Coordinators for consideration of their appointment in the AGM. The AGM approved the proposal and it was decided to authorize National President to appoint such Coordinators/Senior coordinators in consultations with Chief coordinator as per requirement of the work.

VIII. Maintaining transparency in the agriculture sector:

Mr.Manjit Mahadev Lad, Chief Coordinator has mentioned that it is one of the objective of the Association to make all efforts for maintaining transparency and eradication of corruption in the agriculture sector. To work in that line the Chief Coordinator proposed to constitute Anti Corruption Cell(ACC) at AIASA. The Chief Coordinator presented the composition of 15 members ACC headed by Mr.Jitendra Singh Shekhawat and Mr.Ravi Kure as Member Secretary and also its terms of appointment. The proposal was unanimously approved by the AGM. The draft notification was approved in the AGM after discussion. Mr. J.P.Singh, Secretary General raised the issue of harassment of Dr.Sahadeva Singh, President, Technical Officers Association by corrupt bureaucrats in Krishi Bhawan and requested the august gathering to raise the issues with appropriate authority and also proposed to identify the most corrupt officers in the Agriculture Sector. After detailed discussion in the AGM, the consensus was made to declare Mr.P.K.Basu as most corrupt officer of the decade in the agriculture sector. It was also decided to take legal action including PIL for eradication of corruption in the agriculture sector. Shri.Jitendra Singh Shekhawat, Chairman, ACC has been authorized to take up the matter with appropriate authority including Court (s).

The meeting ended with the vote of thanks to the chair.
