Greetings from All India Agricultural Students Association!!

We are very sorry to share that several memorandums submitted by Rajasthan unit of this organization to Hon'ble Chief Minister of Rajasthan through DMs, MLAs and MPs for decreasing the examination fee of Joint Entrance Test (JET) exam for admission in agriculture courses/colleges/university from Rs 2800 to Rs 500. But, Rajasthan government didn't take it seriously. It is well known fact that agriculture is backbone of the economy and mostly students appears from farming community and from rural areas. If examination fee will be high, in such case most of the students will not be able to fill the examination form and talented students from rural area will be the sufferer. In a reply from Agricultural University, Kota, it came to know that such amount of fee is taken for meeting out their examination requirement (**Annexure I**). But, I wish to state that other national level as well as state level exams are taking 5-6 times lower examination fee (Annexure II).

Therefore, It is requested from Central Cabinet and National President, AIASA side to National President, INC to look in to the matter and suggest Chief Minister, Rajasthan for searching alternate way for developing the fund for examination purpose.

Money from rural background community must not be the only way for collecting amount and become the cause for further deteriorating their economic situation. **It is requested to look in to the matter and take necessary measures for decreasing fee up to Rs 500 per students.** All India Agricultural Students Association and agricultural community will be grateful to you.

 - यह जेट फीस वर्ष 2016 से राज्य सरकार की स्वीकृति से महाराणा प्रताप कृषि एवं प्रौद्योगिकी विश्वविद्यालय, उदयपुर द्वारा निर्धारित की गई थी। वर्ष 2016 के बाद इसमें किसी प्रकार की बढ़ोतरी न तो महाराणा प्रताप कृषि एवं प्रौद्योगिकी विश्वविद्यालय, उदयपुर और न ही कृषि विश्वविद्यालय कोटा द्वारा की गई है।
 - इस परीक्षा के आयोजन के लिये कई परीक्षा सेन्टर राजस्थान के विभिन्न शहरों में होने की वजह से एवं ऑनलाईन प्रक्रिया में खर्चा ज्यादा आता है।

2. आवेदन फार्म फीस से तुलना:-

इस परीक्षा के आवेदन फार्म फीस की तुलना राष्ट्रीय स्तरीय परीक्षाओं की आवेदन फार्म फीस से नहीं कि जा सकती क्योंकि उन परीक्षा में बैठने वाले अभ्यर्थियों की संख्या इस परीक्षा में बैठने वाले अभ्यर्थियों की तुलना में कई गुना अधिक होती है अभी जेट के अंदाजीन अभ्यर्थियों की संख्या केवल 30 हजार ही होती है, जिसमें से लगभग आधे आरक्षित वर्ग के होने से फीस सिर्फ आधी ही हैं।
