Hon'ble Sir,

With reference to memo order no (BMC/10320 dated 20.03.2020) from Bhubaneshwar Municipal Corporation(BMC) for use of agriculture research students hostels of OUAT for quarantine purpose and to say that agricultural research students of Orissa University of Agricultural & Technology-Bhubaneshwar has requested this organization for taking up their issues for retaining their hostel rooms, with Government of Odisha. Students have mentioned that they have vacated their hostels in urgency to prevent corona virus infection and left their belongigs particularly research documents; academic forms, electonic gadgets such as laptop, data storage device, pen drives and hard discs in the hostel rooms at OUAT.
