Sub: Suggestion for admission of Undergraduate, Postgraduate and Doctoraee degree Program in Agricultural University during COVID 19.....Reg.

Hon'ble Sir, Greetings!!

On recommendation of central cabinet and State President, of All India Agricultural Students Association, it is to convey you that AIASA does not support admission on the basis of Merit in Undergraduate, Postgraduate and Doctorate degree Program in Agricultural University. However, following points are suggested for your kind consdieration.

- 1. Admission in resepective catgory should be through examination either online or offline mode.
- 2. By keeping consideration, current situation of COCID 19 pandemic in a country, **if examination is not possible**, then semester should not be dropped and admission must be done. Other guidelines, related to classes and examination pattern for next batch can be changed by University, based on ICAR/UGC/University guidelines. In such situation, if examination is not possible, then following points are suggested on behalf of AIASA.
- A. For Admission in Undergraduate, Post Graduate and Ph.D. degree Program, rule of **Equipercentile** rule can be followed.

Whereas, For Undergraduate prgoram, equipercentile can be derived by keeping marks of 12th Examination board (Primarily) or an average marks of 10th and 12th examination board.

Whereas, for admission in Post Graduate - Weightage can be given to marks of 12th examination (20%), 40% weightage to OGPA (B.Sc.) and rest 40% weightage to (3 or 4 specialized subject), for which, students applied in M.Sc. However, Students can opt 3 option for taking admission in M.Sc. in specific subjects.

Whereas, for admission in Ph.D. - 20% Weightage can be given to OGPA (B.Sc.), 80% weightage can be given to Marks of M.Sc.

Based on the above Criteria, average can be derived and after that Equipercentile can be derived based on attach excel sheet. After Equipercentile, list of applicant can be filtered on the basis of State Quota and Reservation quota or based on the seats in their university/state.

For admitting students from other state, Equipercentile can be derived, separately, based on the percent quota of other states.

- 3. Or, any other way, Considederd by University by keeping health and equality of students from different examination systems in a country.
- Note: 1. If students are getting similar equipercentile, in such situation, rule of ASRB/UPSC/University can be followed.
- 2. Highest limit for allowing the criteria of highest percentage (Equivalent to 100) can be considered as 75%.
- 3. If University is going for admission of B.Sc. students based on the equipercentile, In that case, Money can be saved by University from admission of B.Sc. candidates. Therefore, admission for M.Sc. and Ph.D. can be done by increasing number of examination centre. University may use fund of B.Sc. candidates, if rules permit or as per provision in a special case like COIVD 19.
- 4. In Excel sheet, calculation of equipercentile is based on the understanding. If some other standard formula, that can be derived by University/Organization.
